## **Terms of the Tender:**

Heevie organization wishes to purchase the items involved within the tender according to the following regulations:

- 1- The Drug Store must have a valid bank account in the name of the store or the legally authorized representative of the store (the latter should be confirmed by an official letter from the store)
- 2- The tender papers to be presented inside a sealed envelope stamped by the drug store, provided that it is presented in a single envelope bearing the number of tender.
- 3- The materials involved within the tender must be of good origin and have a quality certificate by the quality control department in KRI with a document confirming the success of the material in the testing and examination processes.
- 4- The material shall be in accordance with the specifications in the tender offer list and otherwise, the tender shall be canceled. If any material is found to be in violation of the specifications mentioned upon receipt from the warehouse of the drug store that will be awarded the tender, Heevie shall have the right to cancel the agreement.
- 5- The materials processed must be registered with exemption from the Ministry of Health in KRI.
- 6- The nearest expiry date of the materials should be one year or more from the date of receipt.
- 7- The pharmacist in charge in the drug store that will be awarded the tender, or the pharmacist that replaces him, is required to sign a written document for preparing the materials within one week from the date of the assignment.
- 8- In case of delay in preparing and processing in the agreed period, the drug store shall bear a delay penalty of (100,000) one hundred thousand Iraqi dinars for each day of delay, and in case of delay more than one week, the contract shall be canceled.
- 9- The drug store for which the tender is awarded shall keep the materials stored within its warehouses for a period of not less than 30 days if requested.
- 10- The provided tender must be completed regarding the single and the total accounts, otherwise it will be neglected.
- 11- The drug store for which the tender is awarded should have been taxed with the tax authority.
- 12- The drug store shall bear full responsibility in the event of any physical changes in the material or manufacturing defects, and it will have to be retrieved or replaced.
- 13-Heevie Organization has the right to reduce or increase the required quantities at the time of purchase in accordance with the requirements of the public interest and the existence of the financial support.
- 14-The drug store undertakes that the prices of the materials shall be within the normal rate of prices. Otherwise, it shall bear all the financial and legal implications.
