## **Tender Conditions**

Heevie Organization would like to purchase the mentioned medications based on the following conditions:

- 1- The tender paper must be presented within a sealed envelope with the drug store's official stump; each tender must be presented separately with its own serial number.
- 2- The medications must be of a good manufacturing origin and being approved by the KRG Quality Control Department with an official certification paper.
- 3- In case there is more than one origin of the requested medications, the price and specifications of each one must be revealed.
- 4- The prepared medications must be registered in KRG Ministry of Health.
- 5- The Expire date of each material must not be before December 2017.
- 6- The pharmacist in charge for the drug store or his/her deputy must sign to prepare the medication within one week of duration.
- 7- In case there is any delaying in preparation of medications beyond the date, the drug store will pay fines for each day of delaying which will be 100000 IQD.
- 8- The drug store to be selected must keep the medications in its stores not less than 30 days in case the organization asked for that.
- 9- The tender paper will not be considered unless all the items prices separately and collectively are revealed in the paper.
- 10- The drug store to be selected must be taxed with the tax authorities.
- 11- The drug store to be selected will be responsible for any physical changes occurring on the medications or any manufacturing defects and the drug store shall take those items back or exchange them with better ones.
- 12- Heevie Organization has the right to decrease or increase the amount of the requested medications according to the need and capability.
- 13- The drug store to be selected must assure that all the prices will be within the normal range of prices, otherwise the drug store shall bear all financial and legal implications.
- 14- The drugs listed with the tender papers are the needs for three months, Heevie will select the quantities according to the needs on monthly basis.
- 15- The drug store to be selected will be in charge for transportation of the items to the needed and the final destinations.
